STATEMENT OF WORK/ SPECIFIC PROPOSAL REQUIREMENTS

Laundry Services RFP 17-012

El Paso MHMR d/b/a Emergence Health Network (EHN) has issued this Request for Proposals (RFP) to define minimum contract requirements; solicit responses; detail response requirements; and, outline the agency's process for evaluating response and selecting a contractor to provide the needed goods or services.

Through this RFP, EHN seeks to procure necessary goods or services at the most favorable, competitive prices and to give ALL qualified businesses an opportunity to do business with EHN as contractors, subcontractors or suppliers.

Emergence Health Network (Local Authority) is the Department of State Health Services (DSHS) designated Mental Health Authority established to plan, coordinate, develop policy, develop and allocate resources, supervise, and ensure the provision of community based mental health and intellectual and developmental disability services for the residents of El Paso County, Texas.

EHN operates a twenty four (24) hour Extended Operation Unit (EOU) which is a multi-bed facility that provides up to forty-eight (48) hours of observation and stabilization for individuals who may be experiencing a mental health crisis. A psychiatrist is available if immediate medication or psychiatric intervention is needed. The unit is designed to divert these persons from emergency department utilization and jails to a place where they can receive proper mental health care. Qualified Mental Health Professionals provide or link individuals to those services best suited to their needs. These services may include brief intervention, crisis counseling and support, referral for long-term treatment, and/or referral to the El Paso Psychiatric Center.

A. PROJECT DESCRIPTION/SCOPE OF WORK

The estimated total weekly weight of the Extended Operation Unit laundry is _____ pounds. Prices bid are to be based on per pound clean dry weight. Stated usage figure are estimates for use only as a guideline in preparing your price proposal.

Ragout reports for the laundry service items noted below will be provided to the Extended Observation Unit Manager on a monthly basis; ragout items will be identified prior to disposal.

Standard Requirements

General linen laundry services will include the following:

Flat Goods

Wash, condition, finish, fold and stack: flat sheets, fitted sheets, towels, washcloths, pillow cases, scrub shirts, scrub pants.

Pick-Up and Delivery

- Pick-up of linen is to be provided three (3) days per week. Delivery turnaround time will be three (3) days including weekend delivery. Deliveries falling on legal holidays will be made the weekday immediately following the holiday.

- Delivery time for clean linen will be between the hours of 7:00 a.m. MT and 2:00 p.m. MT, Monday through Sunday.
- Hampers for accumulation of dirty linen shall be provided and located in a central area of the Extended Observation Unit for ease of pickup.
- Clean linen must be delivered in clean hampers that have been lined with polyethylene or other disposable film.

Storage and Handling

- All linens will be processed and handled following all applicable Federal, State and Local laws; the awarded Contractor warrants that all articles to be laundered under this contract will be segregated in the Contractor's place of business and handled separately.
- All articles will be handled in such a manner as to limit any possible shrinkage to not more than one percent (1%) in any direction and to avoid strain, tear or injury of any kind to the fabric.
- All articles received for laundering in a moist or damp condition will be processed promptly (within twelve (12) hours of receipt by awarded vendor), in order to prevent the development of mildew.
- All linens will be washed at a minimum of 160 degrees Fahrenheit, per infection control guidelines.
- All return-delivered laundered articles of linen and laundry will have received a neutral rinse to prevent soapy residue and odors.
- Clean linen shall be folded, stacked and packaged for shipment in a manner that ensures a minimum of wrinkling (i.e., sheets pressed and folded, towels folded; all items loaded into large plastic hampers for return transport to facility).

Additional Information

- The Contractor shall return the same number of articles previously picked up in accordance with the count furnished by the Extended Observation Unit Representative at the time of pickup. Differences in the count of a delivery shall be reconciled before that delivery is completed and a new pickup begun.
- Weekly counts of all items lost and "ragged out" will be provided.
- Awarded Contractor and Extended Observation Unit Representative will conduct a quarterly inventory of linen service delivery count records. A collaborative report of the quarterly inventory will be forwarded to the Purchasing Department.
- Delivery Tickets
 - Contractor shall provide the Extended Observation Unit Representative with a minimum of one (1) original and one (1) copy of each delivery ticket. One (1) copy of the ticket is to be left with the delivery. The original ticket is to be attached to the Contractor's invoice for payment and is to include the following items:
 - Name of Firm
 - Delivery Date
 - Quantity of Articles
 - Unit price per pound (clean, dry weight)
 - Total amount per article
 - Delivery Order Number
- Inspection and Acceptance
 - Delivered linen will be inspected by an Extended Observation Unit Representative. To be considered acceptable, linen must be both clean-looking

and clean-smelling. Clean-smelling will be defined as follows: no chemical or other odor associated with an item's specific use is acceptable; towels and wash cloths must not smell of urine or feces; sheets must not smell as though they had been sealed in plastic and placed in hampers under high temperature.

- Payment will be processed every thirty (30) days upon receipt of a properly submitted invoice(s). Payment will be made based on per pound clean dry weight for those items that were accepted when inspected.
- Linens found to be unacceptable will be returned to the Contractor for re-cleaning and payment will not be made until they have been acceptably cleaned. If unclean or foul-smelling items are found within a batch of linen, the entire batch will be rejected. Payment will be made for accepted linens only.

Proposal Requirements

Vendors need to organize their proposals as defined below to ensure consistency and to facilitate the evaluation of all responses. All the sections listed below must be included in the proposal, in the order presented, with the Section Number listed. The responses shall be submitted in the following format:

References

- a. Provide a minimum of three (3) customer references from individuals for projects similar to the goods or services sought under this RFP.

References from at least three (3) different individuals are required to satisfy the requirements above. The standard reference questionnaire, which must be used and completed, is provided at RFP Attachment 1. References that are not completed as required may be deemed non-responsive and may not be considered.

The Respondent will be solely responsible for obtaining fully completed reference questionnaires and including them in the sealed response. In order to obtain and submit the completed reference questionnaires follow the process below.

- 1) Add the Respondent's name to the standard reference questionnaire at RFP Attachment A and make a copy for each reference.
- 2) Send a reference questionnaire and a standard #10 envelope to each reference.
- 3) Instruct the reference to:
 - Complete the reference questionnaire;
 - Sign and date the completed reference questionnaire;

- Seal the completed, signed, and dated reference questionnaire within the envelope provided;
 - Sign his or her name in ink across the sealed portion of the envelope; and
 - Return the sealed envelope directly to the Respondent (the Respondent may wish to give each reference a deadline, such that the Respondent will be able to collect all required references in time to include them within the sealed response).
- 4) DO NOT open the sealed references upon receipt.
 - 5) Enclose all sealed reference envelopes within a larger, labeled envelope for inclusion in the response as required.

NOTES: EHN will not accept late references or references submitted by any means other than that which is described above, and each reference questionnaire submitted must be completed as required.

EHN will not review more than the number of required references indicated above.

While EHN will base its reference check on the contents of the sealed reference envelopes included in the response, EHN reserves the right to confirm and clarify information detailed in the completed reference questionnaires, and may consider clarification responses in the evaluation of references. EHN is under no obligation to clarify any reference information.

Term

General Provisions

EMERGENCY HEALTH NETWORK

These General Provisions are considered standard language for all EHN proposals and RFP documents. If any “specific proposal requirements” differ from the General Provisions listed here, the “specific proposal requirements” shall prevail.

1. RFP PACKAGE

- a. The PROPOSAL, general and special provisions, drawings, specifications/line item details, contract documents and the proposal sheet are all considered part of the proposal package. Proposals must be submitted on the forms provided by EHN, including the proposal sheet completed in its entirety and signed by an authorized representative by original signature. Failure to complete and sign the proposal sheet/contract page (s) may disqualify the proposal from being considered by EHN. Any individual signing on behalf of the proposal expressly affirms that he or she is duly authorized to tender this proposal and to sign the proposal sheet/contract under the terms and conditions in this proposal. Proposer further understands that the signing of the contract shall be of no effect unless subsequently awarded and the contract properly executed by the CEO. All figures must be written in ink or typed. Figures written in pencil or with erasures are not acceptable. However, mistakes may be crossed out, corrections inserted, and initialed in ink by the individual signing the proposal. Changes must also be made to any electronic copies submitted. If there are discrepancies between unit prices quoted and extensions, the unit price will prevail. Each proposer is required to thoroughly review this entire proposal packet to familiarize themselves with the proposal procedures, the plans and specifications for the requested work as well as the terms, and conditions of the contract the successful proposer will execute with EHN.
- b. Proposal must be received at 9609 Carnegie Ave. BEFORE the hour and date specified. Faxed or e-mailed proposals (without an original paper copy submitted) will not be accepted. Late proposals will not be considered under any circumstances.
- c. Any proposal sent via express mail or overnight delivery must have the Proposal number and title clearly marked on the outside of the envelope or package. Failure to clearly identify your proposal may be cause for disqualification.

2. COMPETITIVENESS AND INTEGRITY

To prevent biased evaluations and to preserve the competitiveness and integrity of such acquisition efforts, proposers are to direct all communications regarding this proposal to the bidquestions@ehnel Paso.org or assigned designee, unless otherwise specifically noted.

An authorized person from the submitting firm must sign all proposals. The signature acknowledges that the proposer has read the proposal documents thoroughly before submitting a proposal and will fulfill the obligations in accordance to the terms, conditions, and specifications.

Please carefully review this Proposal. It provides specific information necessary to aid participating firms in formulating a thorough response.

3. PROPOSER'S RESPONSIBILITY

The proposer must affirmatively demonstrate its responsibility. The proposal must also meet the following minimum requirements:

- Have been in business of providing services for a minimum of 5 years;
- Have adequate financial resources or the ability to obtain such resources as required;
- Be able to comply with all federal, state, and local laws, rules, regulations, ordinances and orders regarding this proposal;
- Have satisfactory record of performance;
- Have a satisfactory record of integrity and ethics; and
- Be otherwise qualified and eligible to receive an award.

4. REJECTION/DISQUALIFICATION OF PROPOSALS

EHN reserves the right to: (1) reject any or all proposals in whole or in part received by reason of this proposal and may discontinue its efforts under this Proposal for any reason or no reason or solely for EHN's convenience at any time prior to actual execution of the contract by EHN. EHN reserves the right to accept or reject all or any part of the proposal, waive minor technicalities, or to award by item or by total proposal; (2) Proposers may be disqualified and rejection of proposals may be recommended for any of (but not limited to) the following causes:

- A. Failure to use the proposal form(s) furnished by EHN, if applicable.
- B. Lack of signature by an authorized representative that can legally bind the company on the proposal form.
- C. Failure to properly complete the proposal.
- D. Proposals that do not meet the mandatory requirements.
- E. Evidence of collusion among proposers.

5. RESTRICTIVE OR AMBIGUOUS SPECIFICATIONS

It is the responsibility of the prospective proposer to review the entire invitation to proposal packet and to notify the EHN if the specifications are formulated in a manner that would restrict competition or appear ambiguous. Any such protest or question(s) regarding the specifications or proposal procedures must be received by EHN no less than seventy-two hours prior to the time set for proposal opening. Vendors are to propose as specified herein or propose an approved equal.

6. SUBSTITUTES

It is not EHN's intent to discriminate against any material of equal merit to those specified however, should the proposer desire to use any substitutions, prior written approval shall be obtained from EHN sufficiently in advance in order that an addendum might be issued.

7. EXCEPTIONS TO PROPOSAL

The proposer will list on a separate sheet of paper any exceptions to the conditions of the proposal. This sheet will be labeled, "Exceptions to Proposal Conditions", and will be attached to the proposal. If no exceptions are stated, it will be understood that all general and specific conditions will be complied with, without exception.

The Proposer must specify in its proposal any alternatives it wishes to propose for consideration by EHN. Each alternative should be sufficiently described and labeled within the proposal and should indicate its possible or actual advantage to the program being offered.

EHN reserved the right to offer these alternatives to other proposers.

8. PRICING

Proposals for equipment shall offer new (unused) equipment or merchandise unless otherwise specified. Quotes F.O.B. destination. If otherwise, show exact cost to deliver (merchandise only). Proposal will be either lump sum or unit prices as shown on the proposal sheet. The net price will be delivered to the EHN, including all freight or shipping charges. In case of error in extension, unit prices shall govern. Proposal subject to unlimited price increases will not be accepted. EHN is tax exempt and no taxes should be included in your proposal. Price should be itemized.

Unless prices and all information requested are complete, proposal may be disregarded and given no consideration.

In case of default by the Proposer, EHN may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the contractor, the difference between the price named in the contract of purchase order and the actual cost thereof to EHN. Prices paid by EHN shall be considered the prevailing market price at the time such purchase is made. Periods or performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the Purchasing Agent.

9. TAX EXEMPTION

Pursuant to Section 151.309 of the Texas Tax Code, EHN qualifies for exemption from sales, excise and use taxes imposed under the Limited Sales, Excise, and Use Tax Act, which is codified at Chapter 151 of the Texas Tax Code. In accordance with Section 151.309, a taxable item sold, leased, or rented to, or stored, used, or consumed by EHN is exempt from the taxes imposed under Chapter 151.

10. MODIFICATION OF PROPOSALS

A proposer may modify a proposal by letter at any time prior to the submission deadline for receipt of proposals. Modification requests must be received prior to the submission deadline. Modifications made before opening time must be initialed by proposer guaranteeing authenticity. Proposals may not be amended or altered after the official opening with the single exception that any product literature and/or supporting data required by the actual specifications, if any, will be accepted at any time prior to the consideration of same. No substitutions or cancellations for merchandise will be permitted without written approval of EHN.

11. SIGNATURE OF PROPOSALS

Each proposal shall give the complete mailing address of the Proposer and be signed by an authorized representative by original signature with the authorized representative's name and legal title typed below the signature line. Each proposal shall include the Proposer's Federal Employer Identification Number (FEIN). Failure to sign the Contract page(s) and proposal response sheet will disqualify the proposer from being considered by EHN. The person signing on behalf of the Proposer expressly affirms that the person is duly authorized to render the proposal and to sign the proposal sheets and contract under the terms and conditions of this Proposal and to bind the Proposer thereto and further understands that the signing of the contract shall be of no effect until it is fully executed by both parties.

12. AWARD OF BID/PROPOSALS-EVALUTATION CRITERIA AND FACTORS

Proposals shall be awarded to the responsible proposer that submits the best proposal.

Proposals will be made to the responsible proposer whose proposal is determined to be the best evaluated offer demonstrating the best ability to fulfill the requirements set forth in a Request for Proposal. The prices proposed will be considered firm and cannot be altered after the submission deadline. **The proposed cost to EHN will be considered firm, unless EHN invokes its right to request a best and final offer and cannot be altered after the submission deadline.**

A Proposer whose proposal does not meet the mandatory requirements set forth in this Proposal will be considered noncompliant.

Each Proposer, by submitting a proposal, agrees that if its proposal is accepted by EHN, such Proposer will furnish all items and services upon the terms and conditions in this Proposal and contract.

Proposer shall submit to EHN, for approval, within ten (10) days from notice of contract award, all Certificates of Insurance evidencing the required coverage as described under Insurance in the schedule of the Proposal.

13. PUBLIC INFORMATION ACT

The parties agree that EHN is a governmental body for purposes of the Texas Public Information Act (TPIA), codified as Chapter 552 of the Texas Government Code and as such is required to release information in accordance with the Public Information Act. Proposer acknowledges that information submitted to EHN is subject to disclosure to third parties as per the requirements of the TPIA.

14. RESULTANT CONTRACT

ANY RESULTANT CONTRACT SHALL BE EXECUTED BY BOTH PARTIES BEFORE TAKING EFFECT. The resultant contract shall become effective upon the execution of the same. The contract documents shall consist of the contract, the general and special provisions, the drawings, proposal package, any addenda issued, and any change orders issued during the work.

The contracts to be entered into between EHN and those whose proposals are accepted shall include, in addition to additional terms as agreed to by the parties, the following provisions:

Governing Law and Venue

Proposer acknowledges that EHN is a governmental agency established under the laws of the State of Texas. The choice of law for any resultant contract shall be the laws of the State of Texas with venue proper in the federal or state courts in El Paso County, Texas.

General Conditions and Stipulations

A. **Indemnification and Worker's Compensation.** The contractor agrees, if the contract is awarded to their organization, the organization shall defend, indemnify and hold harmless EHN, its officials, agents, and employees from and against all claims, damages, losses, and expenses, including attorney fees, arising out of or resulting from the contractor's acts or omission in the performance of the duties required under contract. Proposer acknowledges that EHN, as a governmental agency cannot indemnify third parties as per the requirements of Texas law.

- B. Independent Contractor.** It is agreed nothing herein contained is intended or should be construed in any manner as creating or establishing the relationship of co-partners between the parties hereto or as constitution in the contractor as the agent, representative or employee of EHN for any purpose or in any manner whatsoever. The service pro is to be and shall remain an independent contractor with respect to all services performed under this contract. The contractor represents it has, or will secure at its own expense, all personnel required in performing services under this contract. Any and all personnel of the contractor or other persons while so engaged, and any and all claims whatsoever on behalf of any such person or personnel arising out of employment or alleged employment including, without limitation, claims of discrimination against the service provider, its officers, agents, contracts or employees shall in no way be the responsibility of EHN; and the service provider shall defend, indemnify and hold EHN, its officers, agents and employees harmless for any and all such claims regardless of any determination of any pertinent tribunal, agency, board, commission or court. Such personnel of other persons shall not require nor be entitled to any compensation, rights or benefits of any kind whatsoever for EHN, including, without lamination, tenure rights, medical and hospital care, sick and vacation leave, Worker's Compensation, Unemployment Compensation, disability severance pay.
- C. Miscellaneous.** The proposer agrees to at all times observe and comply with relevant laws, ordinances, regulation, and codes of the federal, state, and local government which may in any manner affect the preparation of the proposals or the performance of the contract.

Right to Terminate

EHN reserves the right to terminate this Agreement subject to thirty (30) calendar days' written notice to the Contractor. Contractor may submit a written request to terminate this Agreement only if EHN should substantially fail to perform its responsibilities as provided herein.

Additionally, EHN reserves the right to terminate-this-Agreement subject to thirty-(30) - calendar-days-written notice to the Contractor should it be later identified as a service which can be consolidated into a statewide/regionalized Agreement. EHN may exercise its option to cancel the remaining years of this Agreement, should it be decided that with additional institutions and/or sites, EHN would receive a better rate for the same service.

However, EHN can immediately terminate this Agreement for cause. The term "for cause" shall mean that the Contractor fails to meet the terms, conditions, and/or responsibilities of the Agreement. In this instance, the Agreement termination shall be effective as of the date indicated on the EHN's notification to the Contractor.

This Agreement may be suspended or cancelled without notice, at the option of the Contractor, if the Contractor or EHN's premises or equipment are destroyed by fire or other catastrophe, or so substantially damaged that it is impractical to continue service, or in the event the Contractor is unable to render service as a result of any action by any governmental authority.

Liability for Loss and Damages

Any damages by the Contractor to an EHN facility including equipment, furniture, materials or other EHN property, will be repaired or replaced by the Contractor to the satisfaction of EHN at

no cost to EHN. EHN may, at its option, repair any such damage and deduct the cost thereof from any sum due Contractor under this Agreement.

Computer Software Management Memo

Contractor certifies that it has appropriate systems and controls in place to ensure that EHN funds will not be used in the performance of this Agreement for the acquisition, operation or maintenance of computer software in violation of copyright laws.

Accounting Principles

The Contractor will adhere to generally accepted accounting principles as outlined by the American Institute of Certified Public Accountants. Dual compensation is not allowed; a Contractor cannot receive simultaneous compensation from two or more funding sources for the same services performed even though both funding sources could benefit.

Liability for Nonconforming Work

All work provided by the Contractor shall conform to the latest requirement of federal, state, and local regulations. Contractor is responsible for compliance with all applicable laws, codes, rules and regulations in connection with work performed under this agreement.

The Contractor will be fully responsible for ensuring that the completed work conforms to the agreed upon terms. If nonconformity is discovered prior to the Contractor's deadline, the Contractor will be given a reasonable opportunity to cure the nonconformity. If the nonconformity is discovered after the deadline for the completion of the project, EHN, in its sole discretion, may use any reasonable means to cure the nonconformity. The Contractor shall be responsible for reimbursing EHN for any additional expenses incurred to cure such defects.

Subcontractor/Consultant Information

Contractor is required to identify all subcontractors and consultants who will perform labor or render services in the performance of this Agreement. Additionally, the Contractor shall notify the EHN liaison in writing within ten (10) working days of any changes to the subcontractor and/or consultant information.

Temporary Nonperformance

If, because of mechanical failure or for any other reason, the Contractor shall be temporarily unable to perform the work as required, EHN, during the period of the Contractor's inability to perform, reserves the right to accomplish the work by other means and shall be reimbursed by the Contractor for any additional costs above the Agreement price.

Extension of Term

If it is determined to be in the best interest of EHN, this Agreement may be amended to extend the term. Upon signing the amendment, the Contractor hereby agrees to provide services for the extended period at the rates specified in the original Agreement. Agreement shall not be set for auto renewal.

15. PROPOSER INVESTIGATION

Before submitting a proposal, each Proposer shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and to verify any representations made by EHN upon which the Proposer will rely. If the Proposer receives an award as a result of its proposal submission, failure to have made such

investigations and examinations will in no way relieve the Proposer from its obligation to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the Proposer for additional compensation.

16. NO COMMITMENT BY EHN

This Proposal does not commit EHN to award any costs or pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a proposal to this proposal, or to procure or contract for services or supplies.

17. SINGLE PROPOSAL RESPONSE

If only one proposal is received in response to the Invitation for Bid or Request for Proposals, a detailed cost proposal may be requested of the single contractor. A cost/price analysis and evaluation and/or audit may be performed of the cost proposal in order to determine if the price is fair and reasonable.

18. CHANGES IN SPECIFICATIONS

If it becomes necessary to revise any part of this proposal, a written notice of such revision will be posted on EHN Purchasing website. EHN is not bound by any oral representations, clarifications, or changes made in the written specifications by EHN's employees, unless such clarification or change is posted on EHN Purchasing website. It shall be the Proposer's responsibility to check the website prior to the proposal opening date to verify whether any addendums have been posted.

19. PROPOSAL IDEAS AND CONCEPTS

EHN reserves the right to adopt or use for its benefits, any concept, plan, or idea contained in any proposal.

20. BID/PROPOSAL DISCLOSURES

Results of proposals for the purchase of goods, materials, general services and construction are considered public information at the time of the proposal opening. All information contained in the proposal response is available for public review.

21. WITHDRAWAL OF PROPOSAL

Proposer may request withdrawal of a sealed proposal prior to the scheduled proposal opening time provided the request for withdrawal is submitted to EHN in writing. No proposals may be withdrawn for a period of sixty (60) calendar days after opening of the proposals.

22. INDEMNIFICATION

A. The Proposer shall be required to notify EHN of any potential for merger or acquisition of which there is knowledge at the time that a proposal is submitted.

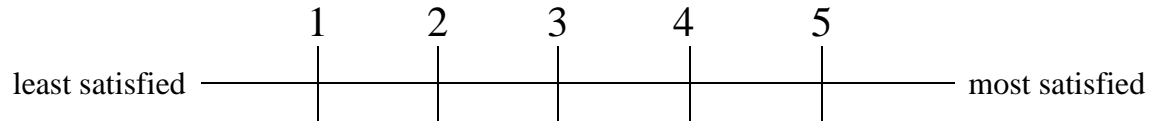
